- b. Activity in Civic Affairs - Local, state, and national participation in civic and service clubs, charitable activities, political action, fraternal or religious groups. (20 points) Previous year prior to Award.

- c. Activity in Local Association – Membership meeting attendance, other meetings and functions attended, Association community outreach projects participation, Association committee work. List any other additional Association participation. (30 points) Previous year prior to Award.
- d. Designations currently held by nominee. (10 points) Previous year prior to award.
