## Guide to Completing the 2025 CBRAR Honor Society Application

The Chesapeake Bay and Rivers Association of REALTORS® (CBRAR) Honor Society was established by the CBRAR Board in 2010 to recognize the achievements of CBRAR REALTOR® members including real estate transactions, education/designations, CBRAR leadership/committee work, and community service.

The Honor Society, sponsored by CBRAR, is comprised of outstanding REALTOR® members who have qualified for membership based on an annual point system. The CBRAR Honor Society is open to CBRAR Primary & Secondary REALTOR® members only. Any CBRAR REALTOR® member meeting the following criteria qualifies for membership:

1. To qualify for the CBRAR Honor Society, a REALTOR® member must obtain a minimum of 100 TOTAL points in a calendar year.
2. **Completed applications must be received by CBRAR Board Office no later than 3:00 p.m., Friday, January 31, 2025. Late submissions will not be accepted. No exceptions!** A completed application is one that:
  - a. Includes CBRAR Honor Society Program Awards Point Form that has been filled out and signed by the applicant and principal or managing broker.
  - b. **Includes supporting documentation for CBRAR transactions, and all items which are not tracked by CBRAR.** EXAMPLES: Designation certificates of completion or print out from NRDS of designation qualification completion, CBRAR education credits, and real estate transactions. Submit CBRAR Honor Society Transaction Points Certified Data Information Form with MLS # printout or HUD/Statement. HUD statement only used in a situation where the property was not listed with any MLS and proof of community service. *All the above must be current for the awards year.*  
**CBRAR Staff OR members of the Awards Committee are not responsible for tracking or reproducing supporting documents that certify agent's participation in any category. It will be the agent's sole responsibility to provide supporting documentation for points represented on the Honor Society Program Awards Point Form. Incomplete applications will NOT be considered.**
3. Education Credits: Education credits may be earned from any of the following options:  
Attending education courses/ lunch and learns offered at CBRAR.  
Attending education courses at other venues.  
Completing education courses on-line.  
Completing NAR certified designation/certification courses and current society designations.
4. Only those activities that were completed between 1/1/2025 and 12/31/2025 qualify for inclusion on the 2025 application form. The only exception to this is professional designations. Applicants MAY claim points for a designation they complete in prior years as long as they are a member in good standing of the society for the designation (i.e., have met all requirements for membership including payment of annual dues in the current award year).
5. The CBRAR Awards Committee reviews all applications and reserves the right to audit at the principal or managing broker's offices to review back-up material supporting submissions. The participating office's records shall be made available to the Awards Committee upon written request. Additional information requested by the Awards Committee from an applicant must be delivered to the Board Office within 5 days of the request to avoid your application being disqualified.

6. Any member transferring from a primary firm to another within the CBRAR, and any secondary member transferring from one firm to another shall be eligible to carry his or her transactions (certified by the member's principal or managing broker) including documentation to be confirmed by the Awards Committee, to his or her new principal or managing broker to qualify for membership in the CBRAR Honor Society.
7. REALTORS® holding primary or secondary membership in the CBRAR must have attained a minimum of 51% of his/her transaction points within a company under the jurisdiction of the CBRAR MLS.
8. To maintain membership in the CBRAR Honor Society, member REALTORS® of CBRAR must earn a minimum of 100 TOTAL points in each calendar year and submit a new application each year. Membership is not automatically renewed.
9. The 2025 CBRAR Honor Society Membership Awards will be presented at an upcoming event. *Tentatively scheduled for April 2<sup>nd</sup>.*
10. **Complete CBRAR Honor Society Award Application Consists of the Following:**
  1. CBRAR Honor Society Program Awards Point Form.
  2. CBRAR Honor Society Transaction Points Certified Data Information Form.
  3. MLS printout with closed data, closing statement for non-CBRAR MLS transactions.
  4. Copies of designation certificates, education certificates, receipts showing RPAC donations, and proof of community service (such as photos, membership lists, letters from the organizations, dues receipts, etc.)
  5. Copy of current real estate license.
11. **Completed applications must be received by CBRAR Board Office no later than 3:00 p.m., Monday, February 2<sup>nd</sup>, 2026. Late submissions will not be accepted. No exceptions!**
