



Emeritus Status Program Application

Emeritus status is offered by REALTOR® associations to recognize an individual's contributions and longevity to the REALTOR® community and industry.

Each level of REALTOR® association -local, state, and national -has its own Emeritus Status program with unique eligibility criteria. Approval for Emeritus Status in one association does not automatically grant Emeritus Status in others.

Criteria

CBRAR honors its longest-serving members with the following criteria, effective in the 2026 billing cycle:

- Any member who has maintained **REALTOR® membership** with CBRAR (or another local REALTOR Association) for at least **40 consecutive years**.
- Provide proof of at least **one year of service** on a committee or board with CBRAR.

Deadline

Applications are due to CBRAR by **July 31st, prior** to the fall billing cycle.

If approved, CBRAR local association dues will be waived. State and National Association dues will still be billed.
